The meeting was held in compliance with the General Circular nos. 20/2020, 14/2020, 17/2020 issued by the Ministry of Corporate Affairs and Circular bearing number SEBI/HO/CFD/CMD1/CIR/P/2020/79 issued by the Securities and Exchange Board of India ("SEBI") and as per the applicable provisions of the Companies Act, 2013 and the Rules made there-under.

Mr. Prashant Sajwani, Company Secretary and Compliance Officer of the Company welcomed all present and highlighted necessary points for joining and conducting the AGM through VC/OAVM.

Thereafter, Mr. Gyan Prakash Govil, welcomed all the members of the Company, quorum being present, declared the meeting open.

He thereafter informed the members that the requisite Statutory Registers are available for inspection to the Members during the AGM and can be obtained by sending an email to the Company. It was then informed that Notice of AGM along with Annual Report for Financial Year 2020-21 had been sent through emails to all the members and was taken as read.

Mr. Prashant Sajwani, Company Secretary and Compliance Officer of the Company, who was present in person at the deemed venue of the meeting, with the permission of the Chair, introduced Directors, and the attendees and thereafter the Chairperson informed the members regarding the business to be transacted at the meeting and asked the Company Secretary to proceed further.

Then, Mr. Ravi Kumar Gupta, Non-Executive - Independent Director of the Company, welcomed all present and handover the proceeding to Mr. Suresh Kumar Dhingra, Executive Director of the Company, who informed the members about the Ordinary and Special Business to be considered in the meeting.

Then, Mr. Prashant Sajwani, Company Secretary and Compliance Officer briefed regarding the arrangements made for the meeting and further informed that the Company has enabled its members to participate in the AGM through the VC facility provided by Central Depositories Services (India) Limited, CDSL. It was further informed that the members were provided with the facility to exercise their right to vote by electronic means, through remote e-voting and e-voting at the AGM in accordance with the provisions of the Companies Act, 2013 and SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015. Members who joined the meeting through VC and who had not cast their vote through remote e-voting were provided the option to vote through e-voting facility made available at the AGM. The Company had appointed M/s Kumar G & Co., Company Secretaries, as Independent Scrutinizer to supervise the e-voting process and to provide combined voting results of remote e-voting and e-voting at the AGM along with the Scrutinizer's Report.

Then he requested to the Mr. Amit Dhuria, Chief Financial Officer to brief about the financial performance of the Company.

Mr. Amit Dhuria presented an overview about the company's financial performance and handover the proceedings to Mr. Dinesh Bhardwaj, Chief Executive Officer of the company express their views on the current and future business plans of the company
